This Certificate Course on Training for Mediation Assessor will enable you to develop essential assessment skills using the CHJMC's Professional Mediator Assessment System, leading to becoming a Mediation Assessor of CHJMC after satisfactorily passing the assessment. Upon the completion of this course, you are expected to be able to:

- Understand the approaches of the CHJMC Professional Mediator Assessment System
- Apply the concepts and details of the Professional Mediation and Cross-border Dispute Resolution Mechanism

- Comprehensive Mediation Skills applicable in the Cross-border Dispute Resolution Mechanism
