





Legal Procedure and the Role of Mediators

Background

In order for mediators to be competent in handling the cases referred to them, mediators should have good understanding of the civil litigation procedure, as well as the time/cost/liability implications of the parties' strategies. Due to the overwhelming favorable response from the first intake organized in November 2013, Hong Kong Mediation Centre will organize a second intake of this course in August 2014.

This course provides mediators with basic understanding of the principles and practices in civil procedures, especially in relation to mediation and the role of mediators in the proceedings.

The objective is to provide mediators who are without legal background to understand the basic principles and procedures in the legal proceedings of civil litigation. While the course is in legal proceedings, the emphasis is on what are the implications of a particular legal procedure on the role of mediators.

Cases are incorporated into the course contents so that participants can have hand-on thinking about what steps a mediator should take in order to avoid adverse legal implications of their actions.

Course Lecturers

Mr. Gary Soo

Gary is a Barrister and civil engineers. He has been practicing in areas of civil and commercial litigation. From 2008 to 2010 he was the Secretary General of the Hong Kong International Arbitration Centre. From 2006 to 2008 he was the President of the Hong Kong Institute of Arbitrators. He is a CEDR Accredited Mediator, Fellow of Chartered Institute of Arbitrator and Hong Kong Institute of Arbitrators. He is also on the panel of arbitrators of the World Trade Center Macau Arbitration Center and a number of arbitration commissions in mainland China. He is the first President of the Guangdong Hong Kong and Macau Mediation Alliance. He is also the Chairman of the Alternative Dispute Resolution Committee of the Hong Kong Bar Association. Gary is a listed panelist for domain name disputes of HKIAC, the China Economic Trade and Arbitration Commission, and the Asian Domain Name Dispute Resolution Centre. Gary is an Adjunct Professor of the Civil Engineering Department of the University of Hong Kong teaching construction law and dispute resolution.

Mr. Damon So

Damon is a Partner of the Hong Kong office of Hogan Lovells, an international law firm, specialising in construction law. He initially qualified as a Chartered Civil and Structural Engineer and is a Member of various professional engineering institutions (namely MHKIE, MICE and MIStructE). He is also a Fellow of the Chartered Institute of Arbitrators and the Hong Kong Institute of Arbitrators. He is the Honorary Legal Advisor to the American Society of Civil Engineers and the Hong Kong Institute of Construction Managers. Since qualification as a solicitor Damon has undertaken a wide range of both contentious and non-contentious construction work and has had occasion to consider many of the issues which typically arise in respect of various construction projects. His contentious work includes a large amount of litigation and arbitration involving numerous expert issues, acting for employers, contractors, statutory bodies, consultants and insurers, in respect of building and civil projects. His non-contentious work includes advising and drafting construction, consultancy and other related contracts for employers, contractors and consultants in respect of a number of building and civil projects using various standard forms of contract. As a Chartered Civil and Structural Engineer, Damon was involved in activities from the whole construction project cycle, including design work, preparing tender and contract documents, cost estimating, site supervision and claims assessment. Damon has spoken widely on topics relating to construction legal issues for various professional institutes and construction companies. He is a co-author of leading textbooks on arbitration namely "The Annotated Ordinances of Hong Kong - Arbitration Ordinance (Cap. 609)" and "Butterworths Hong Kong Arbitration Law Handbook" both published in 2012.

Mr. Iu Ting Kwok

Mr. Iu Ting Kwok (Bachelor of Arts (Hons), Master (with credit) in Arbitration & Dispute Resolution, Fellow of The Chartered Institute of Arbitrators) is a practicing solicitor with "Kwok, Ng & Chan". Besides, he is a HKMAAL mediator (general & family), a HKMAAL family mediation supervisor, a HKMAAL coach, assessor and assistant trainer. TK sat as a Deputy Presiding Officer at the Labour Tribunal between 2002 and 2003. He assisted many employment disputants to reach settlements before the trial hearings. As a practising mediator, he has mediated over 250 cases since April 2010. TK speaks frequently at mediation workshops, seminars and conferences including the 3rd AMA Conference organised by the Hong Kong Mediation Centre. He has authored publications in journals including Tan Pan, Asian Dispute Review, Hong Kong Lawyer and Mediation. TK is a member of the Regulatory Framework Sub-Committee of the Secretary for Justice's Steering Committee on Mediation. Academically, TK is an Adjunct Assistant Professor of JC School of Public Health and Primary Care of the Faculty of Medicine, Chinese University of Hong Kong.

Mr. Richard Leung

Mr. Richard Leung is a practicing barrister with Des Voeux Chambers specialized in company law, commercial law, construction and arbitration litigations and other civil matters. He is also a qualified accountant and chartered secretary. He has over 20 years of working experience first in the accounting field and then in the legal profession. He had occupied senior positions with various entities including KPMG and Hutchison Paging Limited. Since 1996 onwards he has been working in the legal profession practicing as a barrister. Currently he sits a member in various statutory tribunals in Hong Kong including the Board of Review, the Obscene Articles Tribunal, the Appeal Board for the Hotel and Guesthouse Accommodation and so on. He was the former President of the Hong Kong Institute of Chartered Secretaries and is now a Vice Chairman of the Chartered Institute of Arbitrators (East Asia Branch). He is now a director of JMHO representing CIArb (EAB). He has been involved in many mediation cases covering shareholders' disputes, commercial disputes, land disputes, probate disputes, building management disputes, construction disputes and so on and has spoken at conferences/seminars on various topics covering arbitration and mediation practices.
