- 1. To apply for the Professional Mediation Services of HKMC, please fill in and submit the "Professional Mediation Service Application Form" with an administrative fee of HK\$2,000 (suggested to be equally shared by each party) to HKMC.
- 2. The crossed cheque should be made payable to "Hong Kong Mediation Centre Limited"
- 3. HKMC would recommend appropriate mediators for the consideration of every party one by one (maximum 3) in accordance with the guidelines of HKMC and the requirements of parties. In case no mutual agreement is reached between both parties regarding the choice of mediator, they can request HKMC to appoint a mediator to handle the case. An extra amount of HK\$2,000 will be charged for the provision of every three new mediators
