PROFESSIONAL QUALIFICATION

- Participants who successfully complete the course and passing the end-of-course assessment are eligible to apply and register to be enlisted on the IDRRMI (international mediation expert) or/and HKMC (mediator specialist) list, namely the Mediation Specialist in Employees' Compensation.

CERTIFICATION

Upon completion of this specialised course

- Participants attaining 80% attendance in the course and passing the end-of-course assessment will be awarded a "Certificate of Completion".
- Participants with the "Certificate of Completion" are eligible to apply and be enlisted on the Panel of Mediation Specialist in Employees' Compensation at HKMC or/and IDRRMI within a year upon the completion of the course.
- Applicant must fulfil the requirement of entering the professional mediator panel set by HKMC or/and IDRRMI.
