The UNCITRAL Asia Pacific Days is an annual flagship academic series launched in 2014 by the United Nations Commission on International Trade Law Regional Centre for Asia and the Pacific ("UNCITRAL RCAP") to commemorate the December 1966 General Assembly resolution establishing UNCITRAL. The AP Days aim at raising awareness of UNCITRAL's texts and the importance of legal harmonisation amongst law students – the next generation of legal thinkers and policymakers.
